The Office of the City Engineer (OCE) is requesting approval for an Amendment of Professional Services Agreement with Garner & Associates Engineering for engineering services on the University Blvd E Alberta Bridge Lighting project increasing the amount from \$34,000 to \$52,500.

The additional scope will included adding lights along the approach ramps and connect with the existing lighting west of the bridge on University Blvd E.
