Dear Mayor Maddox,

Indian Rivers Behavioral Health is a non-profit community mental health center. We were established in 1969 as a 310 Board per The Alabama Act 310, Code of Alabama 1975, Sections 22-51-1 through 14. We have a volunteer, appointed Board of Directors. Each municipality we serve appoints three members to our Board of Directors, the City of Tuscaloosa, Tuscaloosa County, the City of Northport, Pickens County, and Bibb County.

We are a private/public entity, contracted with the Alabama Department of Mental Health, designed to provide behavioral health services to the citizens of the communities we serve, regardless of insurance or the individual's ability to pay. A large percentage of the services we provide is uncompensated care and we function within a tight budget. However, within that tight budget, we strive to be exceptional in our delivery of the much needed services to the citizens of our communities. Hope Pointe Crisis Care Center is one of the biggest endeavours Indian Rivers has undertaken in decades, and it is a much needed service to our community, literally saving lives. In addition, the services of Hope Pointe will greatly reduce the burden on Tuscaloosa Police, other law enforcement, the jail, and local emergency rooms as individuals in a mental health crisis can be brought to the crisis center rather than tying up law enforcement, going to jail, or tying up needed medical resources in the local emergency rooms.

We are humbly asking for a waiver of the building permit fees for the Phase 2 construction of a second building on the Hope Pointe campus, being developed to expand our capacity to serve more individuals, literally expanding the number of beds we are able to offer. This will enable us to be able to utilize these funds towards the functionality of the services that will be offered in this new building.
