RESOLUTION REVOKING THE BUSINESS LICENSE AND THE PRIVILEGE
TO RENEW THE BUSINESS LICENSE OF RACKD UP LLC D/B/A CRU LOUNGE TUSCALOOSA
LOCATED AT 6571 HIGHWAY 69 SOUTH, UNIT A, TUSCALOOSA, ALABAMA
(OCA-24-0067)

WHEREAS, Rackd Up LLC d/b/a CRU Lounge Tuscaloosa located at 6571 Highway 69 South, Unit A, Tuscaloosa, Alabama 35405, is licensed as Restaurant, Limited Service and Lounge Retail Liquor Class I to do business in the City of Tuscaloosa.; and,

WHEREAS, the City of Tuscaloosa Police Department has received complaints from the public and responded to numerous calls concerning Rackd Up LLC d/b/a CRU Lounge Tuscaloosa. These complaints concern Rackd Up LLC d/b/a CRU Lounge Tuscaloosa having become a public nuisance and dangerous to the public safety, health and welfare; and,

WHEREAS, the City Council by resolution on January 30, 2024 set a public hearing to consider the possible revocation of the business license of Rackd Up LLC d/b/a CRU Lounge Tuscaloosa and the owners were given at least 10 days notice of the hearing; and,

WHEREAS, at the hearing, evidence was presented to establish that Rackd Up LLC d/b/a CRU Lounge Tuscaloosa, was the subject of numerous criminal violations as follows:

1. On January 21, 2024, security guards working on behalf of CRU Lounge got into an altercation with a patron inside the establishment. After the patron was on the ground, those security guards were seen hitting and kicking the man. At least one of the employees of CRU Lounge was present during the assault. Following the assault, one of the security guards shot and killed the assault victim in the CRU Lounge parking lot. That security guard fled the scene following the shooting and has been charged with murder. At least one of the CRU Lounge employees was present and close to the security guard when the shooting occurred. CRU Lounge was not cooperative with police officers as they attempted to investigate the murder. Additionally, CRU Lounge was over its posted occupancy limits on this night.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF TUSCALOOSA as follows:

1. That the licensee, its agents, or employees have violated provisions of State law and municipal ordinance relating to the license or business for which the said license is issued.

2. That the licensee, its agents, or employees have violated or aided in violating or knowingly permitted violations or criminal ordinances of the City and/or criminal laws of the State on a licensed premise.

3. That the licensed business activities are offensive, injurious and dangerous to the public health, safety and welfare to the extent that the licensed premises or licensed activity is a public nuisance.

4. That pursuant to Code of Tuscaloosa Section 7-33, as amended, the following business licenses issued by the City of Tuscaloosa to Rackd Up LLC d/b/a CRU Lounge Tuscaloosa, Account No. 127972 covering Restaurant, Limited Service and Lounge Retail Liquor Class I and/or in the alternative is revoked and the privilege to renew the licenses is hereby revoked.

5. That the Police Department, the Office of the City Attorney and Revenue Department are authorized and directed to take appropriate enforcement action in the event the Licensee continues or attempts to continue business activities at Rackd Up LLC d/b/a CRU Lounge Tuscaloosa.



ORDINANCE NO. _____

**AN ORDINANCE AMENDING CHAPTER 2 OF THE CODE OF TUSCALOOSA
(OCA-24-0054)**

WHEREAS certain employees, by virtue of their positions, are required to act as signors on city bank accounts; and

WHEREAS it is in the interest of administrative efficiency to codify the same,

BE IT ORDAINED BY THE CITY COUNCIL OF TUSCALOOSA as follows:

The following subsections of the Code of Tuscaloosa is hereby amended, and all other sections and/or subsections shall remain unchanged.

SECTION ONE. That Subsection 2-42(b) is hereby amended to read as follows:

“Sec. 2-42. Administration of budget expenditures and funds by chief financial officer.

“(b) *Keeping of accounts.* The chief financial officer shall keep a convenient set of books or records in which there shall be kept a separate accounting for each revenue item of the city. He shall keep a separate account with each department for which a separate appropriation shall have been made, crediting the amount of the appropriation charging warrants drawn against the same. He shall keep such other accounts as may be necessary to show the financial condition of the municipality and of each department thereof at all times. AN ORDINANCE DECLARING CERTAIN PROPERTY SURPLUS
AND AUTHORIZING THE DONATION OF SAID PROPERTY TO
THE TUSCALOOSA CIVIL RIGHTS HISTORY AND RECONCILIATION FOUNDATION
(OCA-24-0128)

WHEREAS, subsequent to the death of Reverend Thomas Linton, (Reverend Linton) the City of Tuscaloosa (City) purchased the Linton Barber Shop Building and all personal items therein belonging to Reverend Thomas Linton; and,

WHEREAS, the City has stored the personal items belonging to Reverend Linton and the Tuscaloosa Civil Rights History and Reconciliation Foundation (Foundation) was requested by the City to inventory, catalog and photograph the items which it has done; and,

WHEREAS, the Foundation has requested that the City donate and transfer the personal items belonging to Reverend Linton to them so that said items may be preserved and for future display as a historical testament to Reverend Linton for his contributions and legacy regarding the Civil Rights History of the City of Tuscaloosa; and,

WHEREAS, the Mayor and City Council likewise believe that the contributions and legacy of Reverend Linton should be preserved and memorialized and it is in the best interest of the City that the Foundation take possession of said items to preserve and honor his heritage and contribution to the Civil Rights History in the City of Tuscaloosa and that the City of Tuscaloosa declare the personal items belonging to Reverend Linton, as described in Exhibit "A" attached hereto, be donated and transferred to the Tuscaloosa Civil Rights History and Reconciliation Foundation for the sum of \$1.00 and other good and valuable consideration.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF TUSCALOOSA that the following items are hereby declared surplus and no longer needed for municipal purposes:
