  - (b) the engagement of Maynard Nexsen PC as bond counsel, and the preparation of the financing and disclosure documents for the Series 2025-A Warrants by such bond counsel;

- (c) the terms, and distribution by the Underwriter, of a preliminary official statement with respect to the Series 2025-A Warrants, on behalf of the City, and upon completion by the City and as approved by the Mayor, Council President, or Chief Financial Officer of the City; and
- (d) the terms and provisions of a warrant purchase agreement (the "Warrant Purchase Agreement") with respect to the Series 2025-A Warrants, by the City and the Underwriter.
- <u>Section 3.</u> <u>Subject to Section 4 hereof</u>, the Mayor, Council President, and the Chief Financial Officer of the City are each hereby authorized and directed to execute and deliver the Warrant Purchase Agreement as well as documents related to the aforementioned engagements listed in Section 2 with respect to the Series 2025-A Warrants.
- **Section 4.** The issuance and sale of the Series 2025-A Warrants by the City shall be subject to:

AN ORDINANCE APPROVING THE DEVELOPMENT PLAN FOR

105 RICE MINE ROAD NORTH (RICE MINE ROAD LOOP), PURSUANT TO

THE RIVERFRONT DISTRICT REGULATIONS

(RD-02-24, OCA-24-1346)

WHEREAS, on August 16, 2024, Development 123 LLC, made an application to the Zoning Officer for approval of a development, within the area of the City of Tuscaloosa zoned Riverfront Development District, for Sports Illustrated Resorts – Tuscaloosa at 105 Rice Mine Road North (Rice Mine Road Loop).

WHEREAS, on September 16, 2024, the Zoning Officer, submitted a report to the Tuscaloosa Planning and Zoning Commission. Said report stated that the Application was reviewed by the Riverfront Advisory Commission at its scheduled meeting on September 5, 2024 and the application was then submitted the Planning Commission pursuant to Section 24-242(C) containing the Zoning Officer's recommendation of the Development; and,

WHEREAS, on September 16, 2024, a public hearing was held by the Tuscaloosa Planning and Zoning Commission to consider the application, as presented by the Developer, Development 123 LLC. The Commission recommended the development for approval by the Council. The Commission reported on the nature and content of its findings and of the development, stating the degree to which the development conforms or fails to conform to the standards set forth in Chapter 24, Article XVIII, and forwarded its report to the City Council; and,

WHEREAS, thereafter the Zoning Officer caused to be made notice of a public hearing, not less than seven (7) days prior to said hearing, to be conducted by the City Council of the City of Tuscaloosa in accordance with the requirements of said Regulations. At which time and place the Zoning Officer did publicly present the report and recommendations of the Planning and Zoning Commission to the City Council, and also did comment upon the Development Plan and answered any questions and comments the Council may have had in regard to the same.

The Developer and/or his representative did then appear on behalf of the application and made a presentation to the Council demonstrating how and in what manner the development conforms to all of the substantive standards for the Riverfront. All other interested parties and persons were then given a reasonable opportunity to be heard on the matter. At the conclusion of said hearing, the City Council did adopt a resolution directing the

City Attorney to prepare an ordinance of a general and permanent nature for the next regular Council meeting approving the development plan subject to certain terms and conditions relating to post-approval compliance and requirements.

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TUSCALOOSA; as follows:

- Substantial Compliance with all specifications outlined in the Application as supplemented by the Development Plan submitted to the Zoning Officer, building in compliance with renderings, elevations, site plan, and Design Development Plans submitted to the Planning Commission and Council and compliance with all applicable requirements, terms and conditions of the Riverfront Development District Regulations, Chapter 24, Article XVIII of the Code of Tuscaloosa.
- 2. The proposed project is a mixed-use development on approximately 19 acres located at 105 Rice Mine Road North (Rice Mine Road Loop). The development includes a 6-story building containing 76 timeshare units and 75 hotel-managed condominium units, 12,000 square feet of retail space in 2 single-story buildings, 6 pickleball courts, as well as parking and several outdoor amenity areas.
- 3. The developer shall construct at its own expense a section of the Riverwalk to City design specifications including landscaping, along the frontage of Rice Mine Loop starting at the intersection of Rice Mine Road NE to the western right-of-way of U.S. Highway 82. Lighting for the path will be provided via pedestrian fixtures mounted on poles along the Riverwalk path. Security cameras and other technology elements are not proposed to be included as a part of the developer constructed improvements; however, the developer will stub out where requested for City installation of security cameras and lighting. Construction of the Riverwalk on lot 1 is deferred until the lot is developed in the future. The developer shall provide at no cost to the City all necessary easements for the Riverwalk.
