ORDINANCE NO. \_\_\_\_\_  
AN ORDINANCE ADDING SECTION 10-13  
TO THE CODE OF TUSCALOOSA  
(OCA-25-0543)

BE IT ORDAINED BY THE CITY COUNCIL OF TUSCALOOSA that Section 10-13 of the Code of Tuscaloosa be and the same is hereby amended to read as follows:

**“Sec. 10-13. – Settlement of minor ordinance violations without trial.**

- (a) *Schedule of fines.* In the event a defendant in municipal court is charged with one of the offenses listed below and elects to plead guilty before a magistrate or pay a parking ticket without contesting it, the following schedule of fines shall apply:
  - (1) *Traffic offenses:*
    - a. Rule 20 (A) of the Alabama Rules of Judicial Administration entitled Schedule of Fines for Traffic Offenses is hereby adopted.
    - b. Other traffic offenses not listed in Rule 20 (A) of the Alabama Rules of Judicial Administration.

No settlement amount or procedure shall apply to the following traffic offenses, each of which shall require a court appearance: a) Operating or being in actual physical control of any vehicle or vessel while intoxicated or under the influence of drugs; b) Reckless driving c) Felony offenses; d)



Operating a motor vehicle while ones driver’s license is suspended, revoked, or canceled; e) Fleeing or attempting to elude and officer; f) Racing on the highway; g) Operating a commercial vehicle after the vehicle or driver has been place “out of service” by a law enforcement officer ; and h) Offenses that carry a penalty that includes mandatory incarceration.
