1. Comply with all specifications outlined in the "Narrative" submitted to the Planning Commission, building in compliance with renderings, elevations and preliminary plat submitted to the Planning Commission and compliance with all conditions in report of Planning Commission to Council.
2. To consist of 73 lots. Typical lots are 45 feet in width and 115 feet in depth, Front Setbacks are 25 feet with side setbacks being 4 feet on each side. Rear setbacks are 30 feet for each lot. Homes will be approximately 2,000 square feet and include two car garages. The pricing is expected to start at \$300,000 to \$375,000.

WHEREAS, the Planning and Zoning Commission held a public hearing at its regular meeting on October 17, 2022 and recommended to the City Council of Tuscaloosa that it grant tentative approval of said Planned Unit Development; and

WHEREAS, a written report of the Planning Commission has been received by the City Council, pertaining to the desirability of the proposed PUD, and recommending tentative approval of the same.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF TUSCALOOSA, as follows:

1. That a public hearing be conducted at 6:00 o'clock, P.M., in the Council Chamber of City Hall, on Tuesday, the 6<sup>th</sup> day of December, 2022, for the purpose of determining whether or not tentative approval of said application should be granted by the Council.

2. That the City Clerk publish a Notice of said public hearing at least one time in *The Tuscaloosa News*, a newspaper of general circulation in the City of Tuscaloosa, not less than seven (7) days prior to the date of said hearing.
